Software Updates

QRDA Cat I R5.1 errata

- **On October 11, 2019 HL7 published an errata update to QRDA Category I R5.1**
 - It is available on the QRDA Category I product page

 - Key updates in QRDA Category I – Introductory Material
 - 6.5.1 – Guidance for Ensuring Data Uniqueness
 - 6.5.2 - Guidance for Reason Template Placement When Specifying “Not Done” with a Reason

Software Updates

Cypress 5.1.0

- **A 5.1.0 patch release for Cypress is planned for November 7, 2019**
- **The Cypress 5.1.0 patch will:**
 - Address the changes made to the QRDA Category I R5.1 errata
 - Address open ‘Known Issues’
 - “Related To” entries split across files (CYPRESS-1716)
 - ‘View Patients’ page only shows results for a single measure/population set (CYPRESS-1799)
 - Calculation Error for CMS104v8 with patient Z4 N Stroke (CYPRESS-1794)
 - Loading bundle crashes Cypress (CYPRESS-1751)
 - With 2019.1.0 bundle

Recent Issues

Cypress 5.1.0 Upgrade

- Users performing a 5.1.0 upgrade of an existing Cypress instance reported still seeing the Calculation Error for CMS104v8.
- This was caused by the upgrade instructions only updating the Cypress Application and not the backend CQM Execution Service.
- If you have already performed the 5.1.0 upgrade please make sure to follow these steps to complete the process.
 - Any tests for CMS104 will need to be regenerated

Connect to your machine running cypress and run the following command:

```
sudo apt-get update
sudo apt-get install cypress
sudo apt-get install cqm-execution-service
sudo systemctl restart cypress
sudo systemctl restart cqm-execution-service
```

Recent Issue

Cypress 5.1.0 Known Issue

- CYPRESS-1868
- CMS165v8
 - <https://ecqi.healthit.gov/ecqm/ep/2020/cms165v8>
 - CQL includes “\$” sort of Blood Pressure exam
- Cypress calculates differently based on the order of entries
 - Issue in the calculation engine
 - Engine does not sort entries properly in order to find the most recent
- Current workaround is to re-order entries

CQL:

      sort by $this
    )
```
