Software Updates QRDA Cat I R5.1 errata

- On October 11, 2019 HL7 published an errata update to QRDA Category I R5.1
 - It is available on the QRDA Category I product page http://www.hl7.org/implement/standards/product_brief.cfm?product_id=35.

 - 6.5.1 Guidance for Ensuring Data Uniqueness
 - 6.5.2 Guidance for Reason Template Placement When Specifying "Not Done" with a Reason

Guidance for Ensuring Data Uniqueness

- The presence of duplicated data in a QRDA Category I file not only could potentially lead to increased data processing time, but most importantly, might cause incorrect processing and therefore produce unexpected measure results when calculated by other entities.
 - Each reported QDM data element contains all of the attributes (e.g., discharge status, facility location, etc.) required by all measures, which are reported in the file, in the same QRDA template for the same instance.

Data Uniqueness and Cypress, continued

Cypress 5.1.0 and beyond

- Will not merge data entries with common IDs.
- Instead, Cypress will treat data entries as duplicative and will pick one entry to use with calculation.
- A QRDA submitter needs to ensure that each reported QDM data element contains all of the attributes (e.g., discharge status, facility location, etc.) required by all measures, which are reported in the file, in the same QRDA template for the same instance.
- As a result, calculations in Cypress 5.1.0 may not match previous calculations in Cypress 5.0.1.
 - If the QRDA files included duplicative QRDA entries.

Guidance for Reason Template Placement

- Specifying "Not Done" with a Reason
- "[...] will be nested directly within the element containing the negationInd attribute."
- When both parent and child template allow negation, should be in *parent* template
- Example Reason Placement:

 - "Related To" entries split across files (CYPRESS-1716)
 - 'View Patients' page only shows results for a single measure/population set (CYPRESS-1799)
 - Calculation Error for CMS104v8 with patient Z4 N Stroke (CYPRESS-1794)
 - Loading bundle crashes Cypress (CYPRESS-1751)
 - With 2019.1.0 bundle


Software Updates Cypress 2019.1.0 Bundle

- A 2019.1.0 bundle release for Cypress is planned for November 7, 2019
 - The Cypress 2019.1.0 bundle will:
 - Include precalculated results for all of the Master Patients
 - Include measure highlighting for all of the Master Patients
 - Add diagnosis entries to Z6 VTE, Z13 N VTE, and B GP Peds to help with C4 Problem Filtering (CYPRESS-1790)
 - Add authorDatetime to 1 BH Infant to address calculation issue with CMS82v7

Now Available: Data Element Definitions for CMS eCQMs for 2020 Quality Reporting/Performance Period on the Collaborative Measure Development Workspace, Data Element Repository

The Electronic Clinical Quality Measure (eCQM) Data Element Repository (DERep) located on the Electronic Clinical Quality Improvement (eCQI) Resource Center now includes information on the Centers for Medicare & Medicaid Services (CMS) eCQMs? for both 2019 and 2020 reporting and performance periods. The DERep contains definitions for standardized eCQM data elements currently used in CMS quality and value-based programs and clearly presents data element definitions for all eCQMs used in CMS's quality reporting programs. The DERep provides clarity for clinicians, quality measurement specialists, health information technology (IT) developers/vendors, and IT staff when representing and mapping data required for eCQMs used in these programs.
