- For the 2022 Reporting and Performance Period
- Release will be 2021 and 2022 compatible
- 2021 bundle (for the 2022 reporting period) can be loaded alongside the the 2020 bundle (for the 2021 reporting period)

- Final Release will be available in all release formats Summer 2021

 - Ability to view calculation results for subpopulations when filtering Vendor and Master Patient Lists (<u>CYPRESS-2218</u>)
 - Ability to view Measure Observation calculations in patient lists, and individual patient calculations (<u>CYPRESS-2236</u>)
 - Removed caching of Vendor Patients which hid updates to uploaded patients (CYPRESS-2212)
 - Validation progress displayed for long running tests
- Validation Updates
 - CVU+ Reporting Period validation updated for CMS529 to reflect CMS Guidance (<u>CYPRESS-2230</u>)
- API Updates
 - Hosting of API Documentation on Cypress Web Server
 - API method to view Cypress Version (<u>CYPRESS-2068</u>)

Software Updates View Measure Observations

- Ability to view Measure Observation calculations in patient lists, and individual patient calculations (<u>CYPRESS-2236</u>)
 - Observed values can be seen in the patient details view. Multiple values from different measurements may be observed in a single episode. The view may also show values from different episodes for the same patient.

Software Updates Validation API

API methods to run CMS/HL7 Schematron validation (<u>CYPRESS-2041</u>, <u>CYPRESS-2133</u>)

- Adds validation endpoint that can be used to post QRDA artifacts for only program-based schematron validation as was available in the previous CVU tool
- Provides validation information as a QRDA validation json response
