Software Updates

Cypress 7.4 (2026 Annual Update)

- **Cypress 7.4.0 for the 2026 Annual Update was released on 6/18/2025**
- **Cypress Features**
 - Supports the §170.315(c)(1), §170.315(c)(2), §170.315(c)(3), and §170.315(c)(4) certification criteria.
 - For the 2025 and 2026 Reporting Period:
 - Supports validation with Health Level Seven International (HL7) Clinical Document Architecture (CDA®) R2 Implementation Guide: Quality Reporting Document Architecture (QRDA) I, Release 1, Standard for Trial Use (STU) Release 5.3 - US Realm.
 - Supports validation with HL7 CDA® Release 2 Implementation Guide: QRDA III, Release 1
 - Supports the eCQMs for eReporting for the 2025 Reporting Period (eCQM value sets as of May 2, 2024).
 - Supports the eCQMs for eReporting for the 2026 Reporting Period (eCQM value sets as of May 8, 2025).
- **Cypress Validation Utility + Calculation Check (CVU+) Features**
 - Supports validation with the CMS Implementation Guides for QRDA Category I – Implementation Guide for 2025 and 2026.
 - Supports validation with the CMS Implementation Guides for QRDA Category III – Implementation Guide for 2025 and preliminary support for 2026.

Updated eCQM Specifications and Implementation Resources for 2026 Performance/Reporting Period

- On May 8, CMS posted the electronic clinical quality measure (eCQM) specifications for the 2026 performance/reporting period
- The updated eCQM specifications are available on the [Electronic Clinical Quality Improvement](#) (eCQI) Resource Center for [Hospital - Inpatient](#), [Hospital – Outpatient](#), and [Eligible Clinician](#) pages under the 2026 performance/reporting period.
- The 2026 performance/reporting period eCQM value sets are available through the National Library of Medicine's [Value Set Authority Center \(VSAC\)](#).
- Program Candidate Measure Information
 - Measures that are developed, but not yet finalized for reporting in a CMS program. These measures will not be eligible for CMS quality reporting until they are proposed and finalized through notice-and-comment rulemaking for each applicable program.
 - The 2026 Annual Update includes 2 Eligible Clinician Program Candidate Measures
 - CMS1154v1 - Screening for Abnormal Glucose Metabolism in Patients at Risk of Developing Diabetes
 - CMS1173v1 - Diagnostic Delay of Venous Thromboembolism in Primary Care

Federal Administrative Sex Value Set

- The eCQMs for the 2026 Reporting Period have been updated to use the Federal Administrative Sex Value Set (2.16.840.1.113762.1.4.1021.121)

Representing Federal Administrative Sex in QRDA

- The HL7 QRDA Implementation Guides restrict the `administrativeGenderCode` element to the codes from the Administrative Gender code system

2. This patient **SHALL** contain exactly one [1..1] `administrativeGenderCode`, which **SHALL** be selected from ValueSet [Administrative Gender \(HL7 V3\)](https://vsac.nlm.nih.gov/valueset/2.16.840.1.113883.1.11.1) urn:oid:2.16.840.1.113883.1.11.1 **DYNAMIC** (CONF:1198-6394).
