- 2. The user authenticates the Health IT Module to the ETT using an incorrect Mutual TLS session (XDR Test 7).

- 6. Using the ETT and Health IT Module logs, the tester verifies the Health IT Module accepts the XDM with the specified MIME type (POP Test 27).
- 7. The tester verifies the Health IT Module accepts attachments (Text, PDF and C-CDA documents) sent from the ETT (POP Test 28).
- 8. The tester verifies the Health IT Module accepts the following C-CDA documents sent from the ETT:
 - o C-CDA document with a broken reference to a style sheet (POP Test 29a); and
 - o C-CDA document with a good reference to the style sheet but an invalid style sheet (POP Test 29b).
- 9. The tester verifies the Health IT Module accepts an XDM package sent from the ETT with bad XHTML (POP Test 30).
- 10. The tester verifies the Health IT Module accepts different attachment types sent from the ETT (POP Test 31).

Paragraph (b)(1)(i)(C) (Conditional) – XDM Processing (Received via Edge Protocol)

System Under Test

Receive XDM Payload

1. Using the ETT "SMTP Tests" for "System as Receiver", the user selects each of the XDM payload attachment types (limited and full metadata) within the ETT and receives an XDM document from the ETT using valid SMTP commands from the username supplied by the Health IT Module email account being authenticated (SMTP Test 20).

Validate XDM Package

2. The user downloads the XDM payload from the SUT, navigates to the ETT Message Validator, XDM Validator, and uploads the XDM payload to the XDM Validator to perform validation of the XDM package.

Test Lab Verification

Receive XDM Payload

1. The tester verifies both a limited and full metadata XDM payload can be successfully received by the Health IT Module from the FTT.

Validate XDM Package

2. Using the ETT XDM Validator with Toolkit, the tester verifies the XDM payload received by the Health IT Module successfully passes XDM validation.

Paragraph (b)(1)(ii)(A)

System Under Test

Receive Payload

1. Based upon the health IT setting(s) to be certified, the Health IT Module receives transition of care/referral summary payloads via the Edge Protocol as specified in (b)(1)(i)(B) for each ambulatory and/or inpatient transition of care (xml) document. All of the transitions of care documents for a given health IT setting must be received (both C-CDA R2 Release 1.1 and C-CDA R2 Release 2.1 formats).

Parse and Process

- 2. The Health IT Module parses each of the following *ambulatory* and/or *inpatient setting* applicable C-CDA document types formatted as a Continuity of Care Document (CCD) in accordance with the standards specified in § 170.205(a)(3) HL7[®] Implementation Guide for CDA[®] Release 2: IHE Health Story Consolidation, DSTU Release 1.1 or a C-CDA § 170.205(a)(4) HL7[®] Implementation Guide for CDA[®] Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1 with one of following document-templates:
 - Continuity of Care;
 - o Referral Note; and
 - *Inpatient setting only*: Discharge Summary.
- 3. The Health IT Module processes the valid document-templates and the data elements required in the corresponding section-templates and entry-templates from the standards adopted in § 170.205(a)(3) HL7[®] Implementation Guide for CDA[®] Release 2: IHE Health Story Consolidation, DSTU Release 1.1 and § 170.205(a)(4) HL7[®] Implementation Guide for CDA[®] Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1.
- 4. Each of these documents includes, at a minimum, as applicable, the following:
 - Common Clinical Data Set;
 - Encounter diagnoses;
 - Cognitive status;
 - Functional status;
 - Ambulatory setting only, the following data elements: reason for referral, and referring or transitioning provider's name, and office contact information; and
 - Inpatient setting only: the discharge instructions.
- 5. The Health IT Module further processes the document for valid document-templates with empty sections and null combinations in accordance with document-templates from the standards adopted in § 170.205(a)(3) HL7[®] Implementation Guide for CDA[®] Release 2: IHE Health Story Consolidation, DSTU Release 1.1 and § 170.205(a)(4) HL7[®] Implementation Guide for CDA[®] Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1 and interprets them correctly.

Negative Testing

6. The Health IT Module receives a series of invalid C-CDA document types via the Edge Protocol (b)(1)(i)(B) for C-CDA R2 Release 1.1 and C-CDA R2 Release 2.1 documents, and correctly parses the invalid documents which contain errors in the "document-templates," "section-templates," and "entry-templates," including invalid vocabulary standards and codes not specified in the standards adopted in § 170.205(a)(3) HL7 Implementation Guide for CDA Release 2: IHE Health Story Consolidation, DSTU Release 1.1 and § 170.205(a)(4) HL7 Implementation Guide for CDA Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1 and reports the errors.

Error Reporting

7. A user is notified or can review the recorded errors encountered during the parsing and processing of C-CDA documents.

Receive Payload

1. Using the ETT: Message Validators - C-CDA R2.1 Validator, the tester downloads the appropriate ONC-Supplied transition of care instruction documents by selecting the "170.315_b1_ToC_Amb", "170.315_b1_ToC_Inp", or "NegativeTesting CCDS" criteria and the file name.

Parse and Process

- 2. For each payload received in step 1, of the SUT, the tester uses the downloaded ONC-Supplied transition of care instruction document downloaded in step 1, and visual inspection to verify that the Health IT Module can successfully receive, parse, and process the applicable types of transition of care/referral summaries formatted as a CCD or a C-CDA with no specific document template according to the standard adopted in § 170.205(a)(3) or as a C-CDA according to the standard adopted in § 170.205(a)(4) with the following document-templates as applicable:
 - Continuity of Care;
 - o Referral Note; and
 - *Inpatient setting only*: Discharge Summary.
- 3. The tester verifies that summaries received, parsed, and processed in step 2, of the SUT contain the data elements required in the corresponding section-templates and entry-templates according to the standard adopted in § 170.205(a)(3) or as a C-CDA according to the standard adopted in § 170.205(a)(4).
- 4. The tester verifies that summaries received, parsed, and processed in step 2, of the SUT also contain the following data elements as applicable:
 - Common Clinical Data Set;
 - Encounter diagnoses;
 - Cognitive status;
 - Functional status;
 - Ambulatory setting only, the following data elements: reason for referral, and referring or transitioning provider's name, and office contact information; and
 - Inpatient setting only: the discharge instructions.
- 5. The tester verifies that valid empty sections and null combinations are used in the C-CDA documents processed in step 2, of the SUT with corresponding section-templates and entry-templates are successfully interpreted in accordance with the standards adopted in § 170.205(a)(3) or § 170.205(a)(4) for each of the following document types:
 - Continuity of Care;
 - o Referral Note; and
 - *Inpatient setting only*: Discharge Summary.

Negative Testing

- 6. Negative Test: For each invalid payload received in step 6, of the SUT, the tester uses visual inspection to verify that the Health IT Module can identify errors in the C-CDA documents not specified in accordance with the standards adopted in § 170.205(a)(3) and § 170.205(a)(4) including:
 - "document -templates;"
 - "section-templates;"
 - o "entry-templates;"
 - invalid vocabulary standards;
 - invalid codes.

Error Reporting

7. Using visual inspection, the tester verifies that errors encountered during the parsing and processing of the C-CDA documents are recorded and that users are either notified of errors encountered OR a mechanism is provided for users to review all of the recorded errors encountered.

Paragraph (b)(1)(ii)(B)

System Under Test

The user is able to view the processed C-CDA documents in section (b)(1)(ii)(A), in human readable format, including the data which is formatted in accordance with the standards specified in § 170.205(a)(3) HL7® Implementation Guide for CDA® Release 2: IHE Health Story Consolidation, DSTU Release 1.1 or § 170.205(a)(4) HL7® Implementation Guide for CDA® Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1. and includes, at a minimum, the following content in English (i.e., non-coded) representation if they associate with a vocabulary/code set, as applicable, for the:

- Common Clinical Data Set;
- Encounter diagnoses;
- Cognitive status;
- Functional status;
- Ambulatory setting only: reason for referral, and referring or transitioning provider's name, and office contact information; and
- Inpatient setting only: the discharge instructions.

Test Lab Verification

Using transition of care/referral summary information retrieved in section (b)(1)(ii)(A) step 1, of the SUT, the tester verifies that for each transition of care/referral summaries received in section (b)(1)(ii)(A)(1), section (b)(1)(ii)(A)(3), and section (b)(1) (ii)(A)(4), the transition of care/referral summaries are displayed accurately and are complete. Furthermore, the tester verifies that the data is formatted in accordance with the standards specified in § 170.205(a)(3) and § 170.205(a)(4) using visual inspection and includes at a minimum the applicable English (i.e., non-coded) representation if they associate with a vocabulary/code set content from the:

- Common Clinical Data Set;
- Encounter diagnoses;
- Cognitive status;
- Functional status;
- Ambulatory setting only: reason for referral, referring or transitioning provider's name, and office contact information; and
- Inpatient setting only: the discharge instructions.

Paragraph (b)(1)(ii)(C)

System Under Test

Display Section Views

- 1. Using the transition of care/referral summaries received and processed in section (b)(1)(ii)(A), the user displays each individual section (and the accompanying document header information) of the received transition of care/referral summaries displayed in section (b)(1)(ii)(B) formatted according to the standards specified in § 170.205(a)(3) HL7° Implementation Guide for CDA° Release 2: IHE Health Story Consolidation, DSTU Release 1.1 or § 170.205(a)(4) HL7° Implementation Guide for CDA° Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1.
- 2. Using the transition of care/referral summaries received and processed in section (b)(1)(ii)(A), the user displays additional sections (and the accompanying document header information) of the received transition of care/referral summaries displayed in section (b)(1)(ii)(B), formatted according to the standards specified in § 170.205(a)(3) HL7° Implementation Guide for CDA° Release 2: IHE Health Story Consolidation, DSTU Release 1.1 and § 170.205(a)(4) HL7° Implementation Guide for CDA° Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1.
- 3. Using the transition of care/referral summaries received and processed in section (b)(1)(ii)(A), the user can display data from a particular section.

Section Order

- 4. The user uses the Health IT Module to set the preference for the display order of specific sections for each of the supported document types.
- 5. The user uses the Health IT Module to demonstrate that the sections displayed for the transition of care/referral summaries received and processed in section (b)(1)(ii)(A) are ordered correctly based upon the section order preference set in step 4.

Quantity of Sections

- 6. The user uses the Health IT Module to set the initial quantity of sections to be displayed.
- 7. The user uses the Health IT Module to demonstrate that the initial number of transition of care/referral summary sections displayed corresponds to the quantity of sections set in step 6.

Test Lab Verification

Display Section Views

- 1. Using visual inspection, the tester verifies that the transition of care/referral summaries received and processed in section (b)(1)(ii)(A) can accurately and without omission display the data from an individual section and its accompanying document header information.
- 2. Using visual inspection, the tester verifies that for the transition of care/referral summaries displayed in step 1, of the SUT, the user can select data from an additional individual section or sections to be displayed, along with its accompanying document header information, and that the data is accurate and without omission.
- 3. Using visual inspection, the tester verifies that data first displayed in step 1, of the SUT is for one particular section of the document for each document type.

Section Order

- 4. Using visual inspection, the tester verifies the user has the ability to set the order in which the transition of care/referral summary sections are displayed for each of the supported document types.
- 5. Using visual inspection, the tester verifies that the sections displayed for the transition of care/referral summaries received and processed in section (b)(1)(ii)(A) are ordered correctly based upon the section order set in the previous step (step 4, of the TLV). The sections are displayed in the preferred order.

Quantity of Sections

- 6. Using visual inspection, the tester verifies the user has the ability to set the initial quantity of sections for a transition of care/referral summary to be displayed.
- 7. Using visual inspection, the tester verifies that the number of transition of care/referral summary sections initially displayed in step 1, of the SUT corresponds to the quantity of sections to be displayed in step 6, of the SUT.

Paragraph (b)(1)(iii)

System Under Test

Data Entry

1. Based upon the health IT setting, the health IT developer uses the ETT: Message Validators - C-CDA R2.1, to download the appropriate ONC-Supplied transition of care instruction documents by selecting the "170.315_b1_ToC_Amb" or "170.315_b1_ToC_Inp" criteria, selecting the file name, and executes the download. The user enters the transition of care information downloaded in order to create a patient record with the necessary information.

Create

- 2. Using the Health IT Module, the user sends a transition of care document using one of the transport mechanisms specified in section (b)(1)(i)(A) as a C-CDA document, which contains a transition of care/referral summaries, formatted according to the standard adopted in § 170.205(a)(4) HL7 Implementation Guide for CDA Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1, in the following formats as applicable:
 - Continuity of Care;
 - o Referral Note; and
 - *Inpatient setting only*: Discharge Summary.
- 3. At a minimum, the C-CDA document created in step 2, includes the following content in accordance with the specified standards as applicable:
 - Common Clinical Data Set as specified in section (b)(1)(iii)(A);
 - Encounter diagnoses as specified in section (b)(1)(iii)(B);
 - $\circ \quad \text{Cognitive status as specified in section (b)(1)(iii)(C);}\\$
 - Functional status as specified in section (b)(1)(iii)(D);
 - Ambulatory setting only, the following data elements: as specified in section (b)(1)(iii)(E):
 - The reason for referral; and
 - Referring or transitioning provider's name, and office contact information.
 - o Inpatient setting only: the discharge instructions as specified in section (b)(1)(iii)(F); and
 - Patient match data as specified in section(b)(1)(iii)(G).
- 4. Based upon the supported health IT setting(s), the user repeats steps 1-3, for each of the ambulatory and/or inpatient transition of care instruction documents found in the ETT: Message Validators. A transition of care document must be sent for every transition of care instruction document for a given health IT setting.

Data Entry

1. For each transition of care payload sent by the SUT, the tester uses the transition of care/referral summary information document downloaded in step 1, of the SUT and visual inspection to verify that the transition of care/referral summary record information entered into the Health IT Module is accurate and without omission.

Create

- 2. For each transition of care payload sent by the SUT via Edge Protocol as specified in section (b)(1)(i)(A), the tester verifies the content of the transition of care/referral summary using the Message Content Report within the ETT. The tester verifies that for each applicable payload no errors exist in the Message Content Report indicating the Health IT Module can successfully create a payload which conforms to the transition of care/referral summary in accordance with the standard specified at § 170.205(a)(4) and that the document sent is either a CCD document, a Referral Note, or (inpatient setting only) a Discharge Summary.
- 3. Using the Message Content Report from the ETT and the transition of care/referral summary instruction documents used to create the payload, the tester uses visual inspection to verify the additional checks for equivalent text for the content of all section level narrative text. The content of each narrative text data element must match the content specified in the transition of care/referral summary instruction document.
- 4. Using the Validation Report from the ETT, the tester verifies that for each supported health IT setting the following type of transition of care/summary care records have been created by the SUT:
 - Continuity of Care Document (CCD);
 - o C-CDA R2 R2.1 Referral Note Document; and
 - Inpatient setting only: C-CDA R2 R2.1 Discharge Summary.

Paragraph (b)(1)(iii)(A)

System Under Test

The Common Clinical Data Set

The content of the transition of care/referral summaries created in Data Elements and Vocabularies applicable to the Common Clinical Data Set (CCDS) section (b)(1)(iii) contains the Common Clinical Data Set where applicable and represent such data in accordance with the standards specified in the CCDS Reference Document for C-CDA R2 R2.1 documents.

Test Lab Verification

The verification that the Common Clinical Data Set content is in accordance with the standards specified in the CCDS Reference Document for a document specified in accordance with § 170.205(a)(4) HL7® Implementation Guide for CDA® Release 2: Consolidated CDA Templates for Clinical Notes, DSTU Release 2.1, is performed as part of the verification done in section (b)(1)(iii) steps 2-3, of the TLV.

Paragraph (b)(1)(iii)(B)

System Under Test

Encounter Diagnoses

The content of the transition of care/referral summaries created in section (b)(1)(iii) contains the Encounter diagnoses using at least one standard, either:

- the standard specified at § 170.207(i) ICD-10-CM for the following conditions:
 - Diseases;
 - Injuries;
 - o Impairments;
 - Other health problems and their manifestations;
 - Causes of injury, disease, impairment, or other health problems.
- or at a minimum the version of the standard specified at § 170.207(a)(4) SNOMED CT[®].

Test Lab Verification

The verification that the Encounter diagnoses content is specified in accordance with the constrained standard specified at § 170.207(i) or at a minimum the version of the standard specified at § 170.207(a)(4) is performed as part of the verification done in section (b)(1)(iii) steps 2-3, of the TLV.

Paragraph (b)(1)(iii)(C)

System Under Test

Cognitive Status

The content of the transition of care/referral summaries created in section (b)(1)(iii) contains the Cognitive status when present.

Test Lab Verification

The verification of the Cognitive status content of the transition of care/referral summaries is performed as part of the verification done in section (b)(1)(iii).

Paragraph (b)(1)(iii)(D)

System Under Test

Functional Status

The content of the transition of care/referral summaries created in section (b)(1)(iii) contains the Functional status when present.

Test Lab Verification

The verification of the Functional status content of the transition of care/referral summaries is performed as part of the verification done in section (b)(1)(iii).

Paragraph (b)(1)(iii)(E)

System Under Test

Ambulatory Setting Only

The content of the transition of care/referral summaries created in section (b)(1)(iii) contains the reason for referral, referring or transitioning provider's name, and office contact information.

Test Lab Verification

The verification of the data element requirements for the *ambulatory setting* within a transition of care/referral summaries is performed as part of the verification done in section (b)(1)(iii). This includes verifying the transition of care/referral summaries record includes: the referring or transitioning provider's name and Office contact information. Additional verification is done in section (b)(1)(ii) step 3, of the TLV to verify the unstructured text data element Reason for Referral.

Paragraph (b)(1)(iii)(F)

System Under Test

Inpatient Setting Only

The content of the transition of care/referral summaries created in section (b)(1)(iii) contains the discharge instructions.

Test Lab Verification

The verification of the required discharge instructions content for the *inpatient setting* within a transition of care/referral summaries is performed as part of the verification done in section (b)(1)(iii) step 3, of the TLV.

Paragraph (b)(1)(iii)(G)

System Under Test

Patient Matching Data

The content of the transition of care/referral summaries created in section (b)(1)(iii) contains the following patient matching data:

- Full name including first name, last name, previous name, middle name (including middle initial), and suffix;
- Date of birth including the year, month, and day when known and null when unknown.
- Address;
- Phone number(s) which are constrained in accordance with the standard specified at § 170.207(q)(1) ITU-T E.123 and ITU-T E.164, and if multiple phone numbers are present within the Health IT Module they are reflected in the transition of care/referral summaries; and
- Birth sex which is constrained in accordance with the standard specified at § 170.207(n)(1) Birth sex coded in accordance with HL7® Version 3 Value Sets for Administrative Gender and NullFlavor attributed as follows:
 - (i) Male. M
 - (ii) Female. F
 - (iii) Unknown. nullFlavor UNK

The verification of the patient matching data within the transition of care/referral summaries created in section (b)(1)(iii) includes the following checks presence of the patient's first name, last name, previous name, middle name (including middle initial), suffix, date of birth, address, all phone number (s) present in the Health IT Module and sex, as applicable. Furthermore, the phone number(s) are constrained in accordance with the standard specified at § 170.207(q)(1) and the birth sex is in accordance with the standard adopted in § 170.207(n)(1).

Paragraph (b)(1)(iii)(G)(1)(ii) Optional

System Under Test

Birth with Time

If the time of birth (hours, minutes, and seconds) is included the correct time zone offset is used.

Test Lab Verification

If the Health IT Module supports the time of birth, the tester verifies that the Health IT Module can demonstrate the correct time zone offset as part of the time of birth.
