Lauren Richie turned the meeting over to Andy Truscott, co-chair.

Andy Truscott slightly altered the agenda to focus on the definition of electronic health information.



ELECTRONIC HEALTH INFORMATION

Andy Truscott initiated the conversation by suggesting an additional item be added to the definition of electronic health information.

• Administrative or financial information which may include pricing information that is not identifiable to a specific individual but that may be relevant to the care decisions of or for an individual.

There was significant discussion around price transparency with one minority point of view.

- **Cynthia Fisher** shared her insight that price transparency is essential.
- **Sheryl Turney** noted that it seemed that the task force is losing focus of the charge and expressed concern about broadening this scope.
 - o Anil Jain and John Kansky made similar points.
- Sasha TerMaat suggested that price transparency should be defined outside of this definition of electronic health information.
- **Denise Webb** noted her appreciation for Cynthia Fisher's perspective but agreed with Sheryl Turney's point of view noting that if it is too broad, it will not be implementable.
- Valerie Grey shared that she also believes there is a need for better price transparency, but she agreed with most of the member's insight. She noted that this is difficult which is why there is a request for information around price transparency.

Andy Truscott suggested sharing a divergent minority opinion with ONC that expresses Cynthia Fisher's viewpoint.

Cynthia Fisher expressed concern that there was a missing voice on the call to represent technology innovation.

- **John Kansky** and **Anil Jain** both commented that they felt they both represent technology innovation.
- Anil Jain suggested changing the point of view to identify whether the current language is sufficient to do this is a way that makes sense. His concern is harming innovation and creating a challenging process in the future.

Anil Jain suggested that he would prefer a majority proposal without a minority. He suggested putting Cynthia Fisher's opinion into the discussion.

Andy Truscott asked for a vote to include the divergent minority opinion.
