Review Draft Recommendations

Proposed enhancements to recommendations 5, 7A, 7B, 8A, 8B, 10, 11, 12A, and 12B were identified and discussed.

RECOMMENDATION 5

The following revisions were proposed:

- Remove the functional requirements listed in Recommendation 5 and move them into an entirely new section within the transmittal letter.
- Clarify that the Qualified Health Information Network (QHIN) Technical Framework (QTF) is a list of potentially relevant standards but note that they are non-binding.
- Clarify that the Recognized Coordinating Entity (RCE) should be allowed to choose any technical enablement(s) of the functional requirements within the QHIN Exchange Network.

RECOMMENDATIONS 7A AND 7B

- The discussion focused on the specialization of QHINs. Many members noted the necessity of general purpose QHINs and others favored specialized QHINs, stating that they will promote the importance of the trusted exchange framework (TEF).
- To better illustrate the need for QHIN specialization a visual representation to include Health Record Bank and Public Health use cases will be made and presented to members of the task force.

RECOMMENDATIONS 8A AND 8B

The following revisions were proposed:

- Update recommendation 8A to the following "additional use cases to incorporate must include" rather than "may include."
- The following revised recommendation 8B was proposed: "The TF recommends that ONC define
 the individual engagement goals for the TEFCA to include: access, amendment, PGHD, and data
 donation. We acknowledge that the system is more ready for Individual Access Services (IAS) and
 think it is appropriate to get started for IAS. ONC and the RCE should put energy into expanding
 the use cases."
- A consensus recommendation will be drafted to include parts of both recommendation 8A and 8B.

RECOMMENDATION 10

The following revisions were proposed:


- Flexibility for public health agencies is contradictory to the strict demands of QHINs, and the expectations should be made more uniform.
- The recommendation should be based on surveillance cases where a public health agency may get electronic health information (EHI).
- Exclude immunization registries from recommendation 10 and articulate the discussion of the topic elsewhere in the letter.

RECOMMENDATION 11

The following revisions were proposed:

Reframe the recommendation to emphasize the most significant bullets.

RECOMMENDATIONS 12A AND 12B

- Discussion surrounded concerns about the inability of implementing recommendation 12B as it conflicts with already written laws. Specifically, it conflicts with the definition of meaningful choice with regard to it being revocable on a prospective basis.
- Task force members were asked to consider which of recommendation 12A or 12B could be deleted and to communicate their preference to either co-chair at their earliest convenience.
