# HITAC Priority Target Areas: Defined in the Cures Act

- **Interoperability** – Achieving a health information technology infrastructure that allows for the electronic access, exchange, and use of health information
- **Privacy and Security** – The promotion and protection of privacy and security of health information in health IT
- **Patient Access** – The facilitation of secure access by an individual and their caregiver(s) to such individual's protected health information
- Any other target area related to the above target areas that the HITAC identifies as an appropriate target area to be considered on a temporary basis with adequate notice to Congress

- Create new Task Force to provide recommendations on draft EHR Reporting Program criteria (2020, *pending criteria release*)

## Federal Health IT Strategic Plan 2020-2025

- ONC present public comment draft of Strategic Plan for full HITAC feedback (2020, *pending Strategic Plan release*)

Topic	Potential HITAC Action
<b>Priority Uses of Health IT &amp; related Standards</b>	Continue HITAC work on priority uses of health IT and related standards (e.g., ISP Task Force or new Task Force)
<b>Prior Authorization*</b>	Establish a joint HITAC/NCVHS Task Force on prior authorization
<b>U.S. Core Data for Interoperability</b>	TBD, pending ONC consideration of final USCDI expansion model recommendations & ONC final rule publication
<b>Trusted Exchange Framework and Common Agreement</b>	TBD, pending ONC and Recognized Coordinating Entity work planning
<b>ONC Final Rule Implementation Guidance</b>	TBD, pending ONC final rule publication
<b>Price Transparency / Intersection of Clinical &amp; Administrative Data Standards*</b>	Establish new HITAC Task Force or continue ISP Task Force to address price transparency
<b>Data Privacy / Secondary Uses of Data*</b>	Convene HITAC hearing on secondary uses of data

\*Action on these topics would be contingent on additional ONC coordination across HHS
