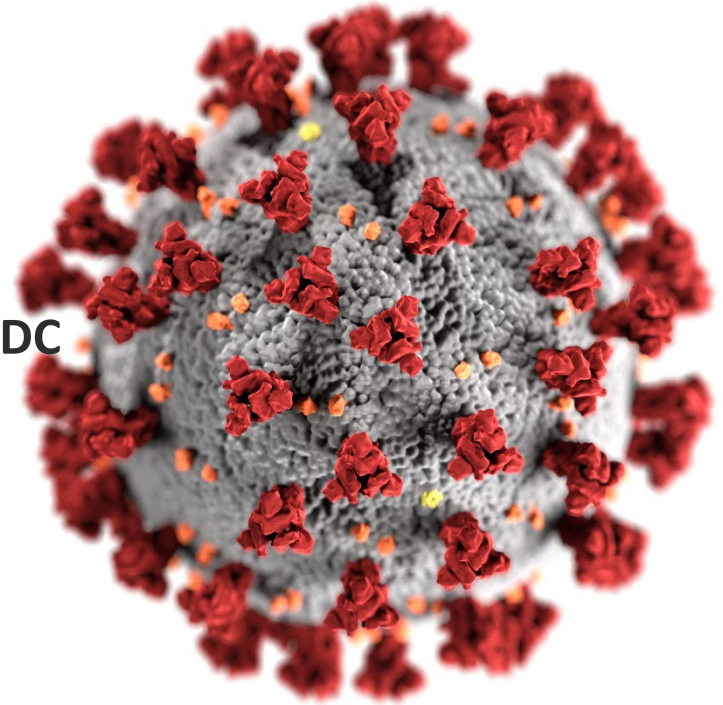

What Is Electronic Case Reporting (eCR)?

The **automated generation** and transmission of case reports from the electronic health record (EHR) to public health agencies for review and action



eCR Now



eCR Now for COVID-19

- eCR is a critical tool for COVID-19 and other reporting needs to state and local public health agencies
- Critical clinical data for outbreak management includes:
 - Patient identity and contact information
 - Co-morbidities
 - Race and ethnicity
 - Occupation
 - Pregnancy status
 - Travel history
 - Other clinical data – medications, immunizations
- eCR provides clinical data on patients to state and local public health agencies they need for action

eCR Now Elements

- 1. Rapid cohort-based COVID-19 eCR implementation** for provider sites that have eCR enabled EHRs
- 2. eCR Now FHIR App** that other EHRs can use to do electronic case reporting
- 3. Nationwide eCR trust framework** for eHealth Exchange, Carequality, CommonWell members, and those who connect to them

eCR Now - Element 1

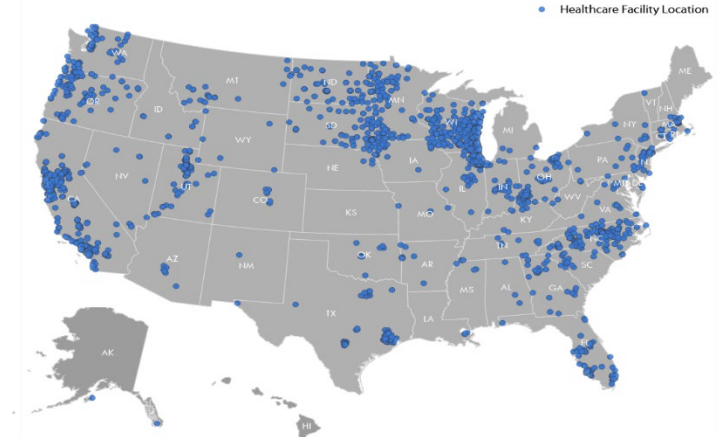
Rapid cohort-based COVID-19 eCR implementation for provider sites that have eCR enabled EHRs

- A standard ask for patient data from all jurisdictions implemented in as little as 3-5 days

eCR by the Numbers*

59

All 50 states, DC and 8 large local jurisdictions have published a rule for COVID-19 and can receive electronic initial case reports from AIMS

57

Jurisdictions of 59 have received at least one COVID-19 report from eCR

4,800+

Facilities have implemented eCR for COVID-19

1.65M+

Reportable COVID-19 reports have been sent to 57 public health agencies

eCR Now - Element 2

eCR Now FHIR App that other EHRs can use to do electronic case reporting

- For EHRs that do not otherwise have eCR capabilities
- Works with the FHIR DSTU2 or R4 APIs
- Being implemented now in major commercial EHRs
- Can be also implemented by health systems or third parties

eCR Now - Element 3

Nationwide eCR trust framework for eHealth Exchange, Carequality, CommonWell members, and those who connect to them

- No additional legal agreements needed
- An APHL participation agreement for those not connected to any network
- No additional costs for the use of the eCR shared services
- Have not seen COVID-19 charges from EHR vendors

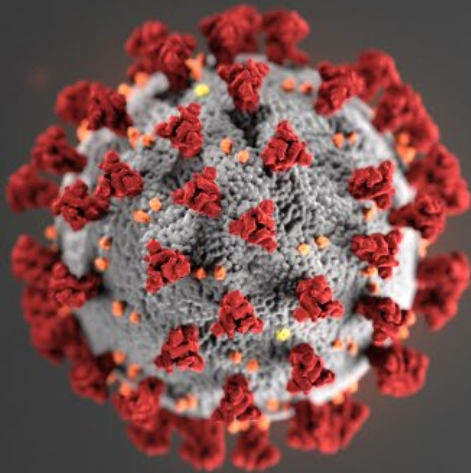

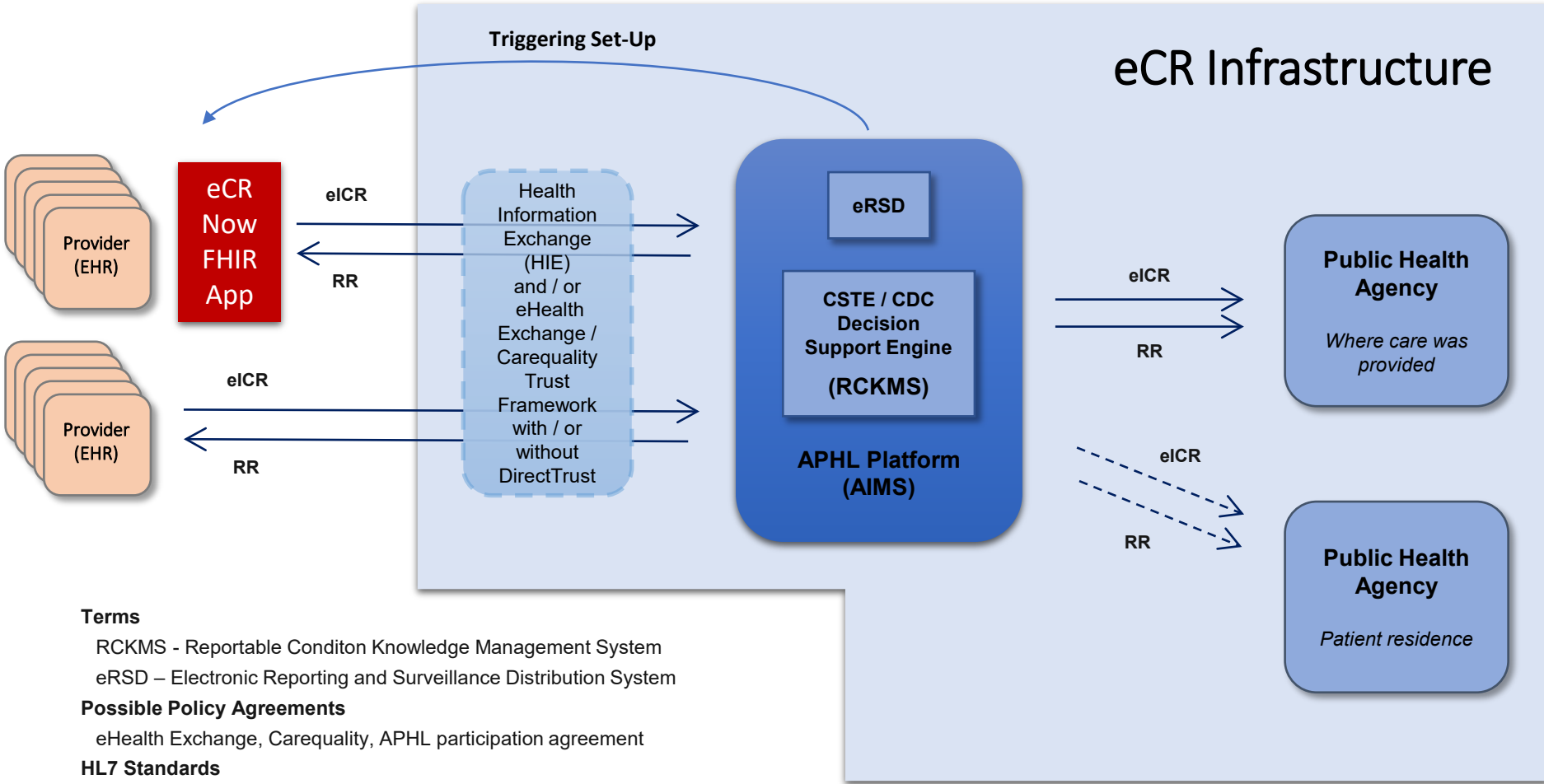
