# Potential Topics for HITAC Annual Report for FY21

- Topics to carry over from Annual Report for FY20
  - ONC Activities: ONC Cures Act final rule, TEFCA program, EHR Reporting Program
  - Bidirectional exchange of health data for public health purposes, for research, and across the care continuum
  - Exchange of social determinants of health (SDOH) data
  - Patient matching
  - Data needs for increased health equity
  - Privacy and security for public health purposes
  - Beyond HIPAA: Rules for sharing, patient consent, Internet of Things (IoT)
  - Patient safety of EHRs and mobile health applications
  - Sharing and correcting incorrect clinical data
  - Use and sharing of patient-generated health data (PGHD)

# Potential Topics for HITAC Annual Report for FY21

- From HITAC members' comments to date in FY21
  - Use of Technologies that Support Public Health
    - Population-level reporting, especially for immunization data, using public health data systems
    - Incentives for public health data sharing
    - Alignment of clinical and public health datasets
    - Electronic lab reporting (ELR) and electronic case reporting (ECR)
    - Information exchange to facilitate care and monitoring of patients with “long COVID-19”
    - Future needs beyond the COVID-19 response, including workforce
