




Registered Eligible Hospitals






Paid Eligible Hospitals






Registered Eligible Professionals

EHR Incentive Program Trends


- Approximately <u>88% of all eligible hospitals</u> have received an EHR incentive payment for either MU or AIU
 - Nearly 9 out of 10 eligible hospitals have made a financial commitment to an EHR
- Approximately 60% or <u>3 out of every 5 Medicare EPs</u> are meaningful users of EHRs
- Approximately 78% or nearly <u>4 out of every 5 Medicaid EPs</u> of have received an EHR incentive payment
 - •20% of Medicaid EPs are meaningful users
- Almost 63% -- 3 out of every 5 Medicare and Medicaid EPs have made a financial commitment to an EHR
- Over 340,000 Medicare and Medicaid EPs have received an EHR incentive payment




Hospital 1st v. 2nd v. 3rd year Core Objective Performance






Hospital 1st v. 2nd v. 3rd year Menu Objective Performance






EP 2011, 2012, and 2013 90 Days Core Objective Performance
