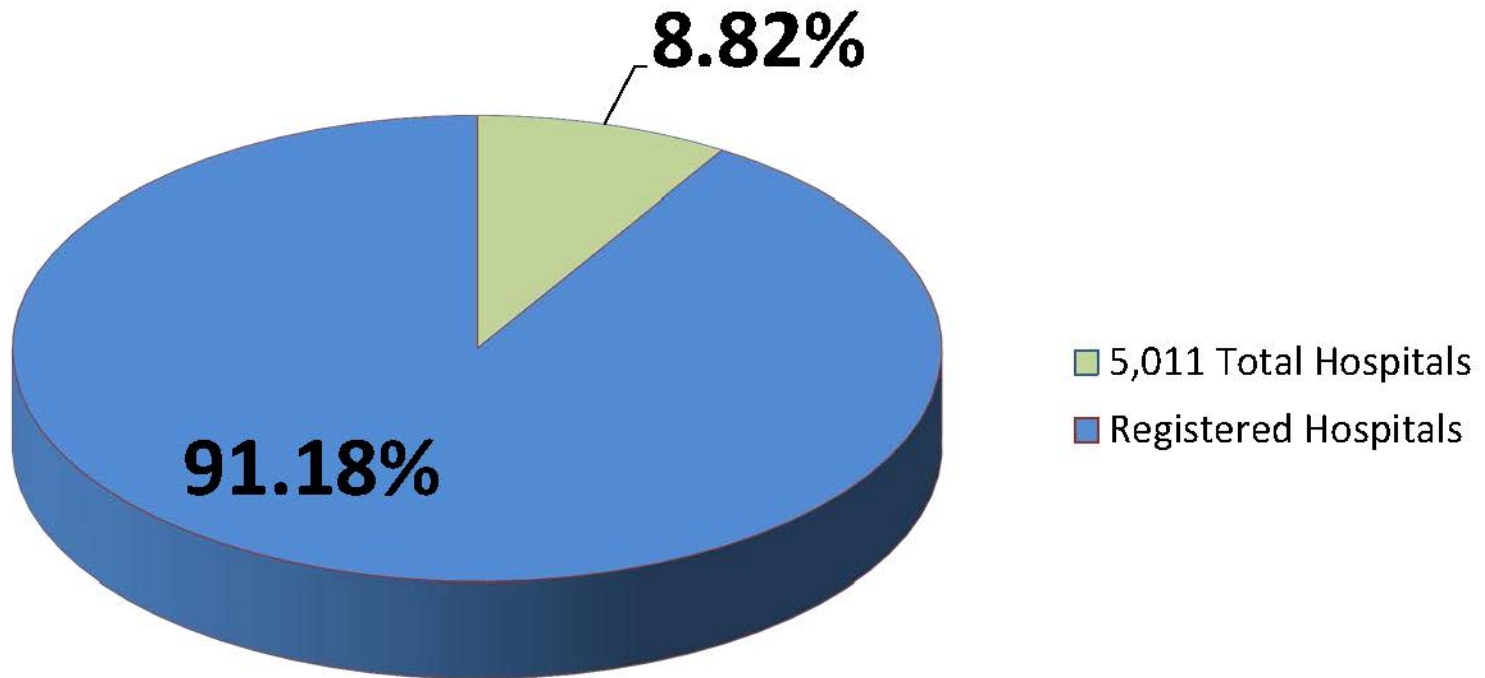

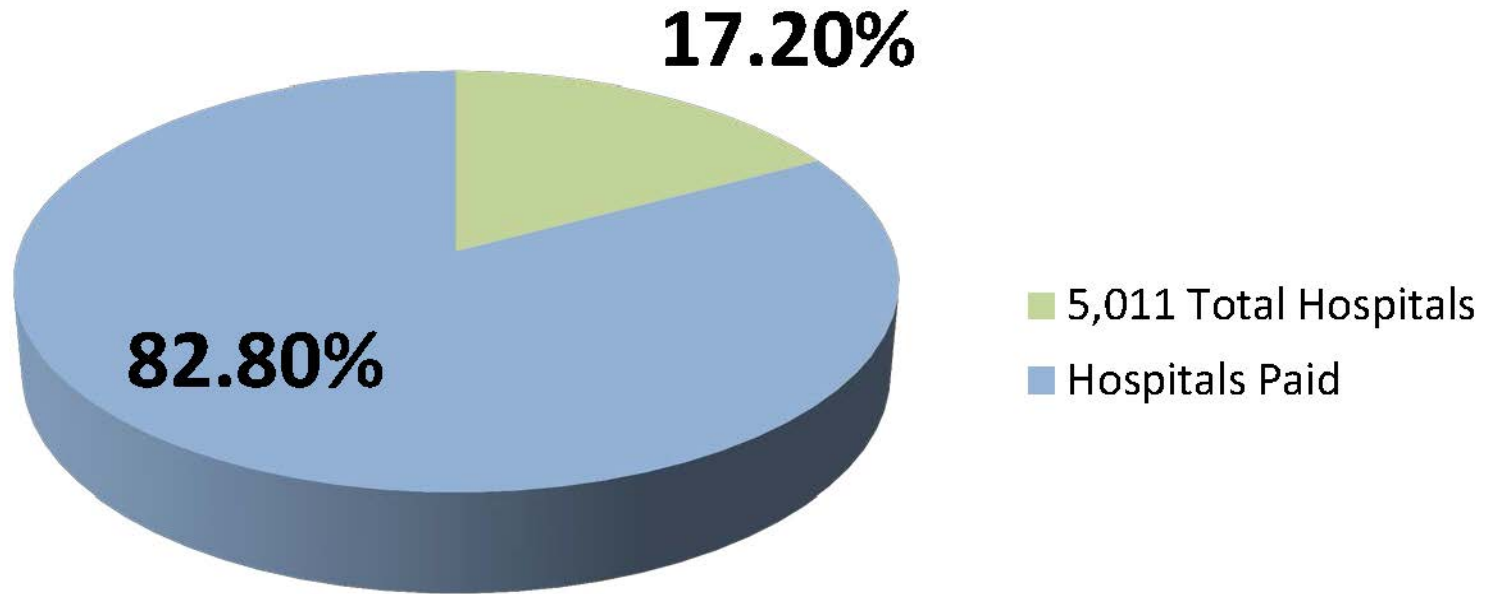
Registered Eligible Hospitals

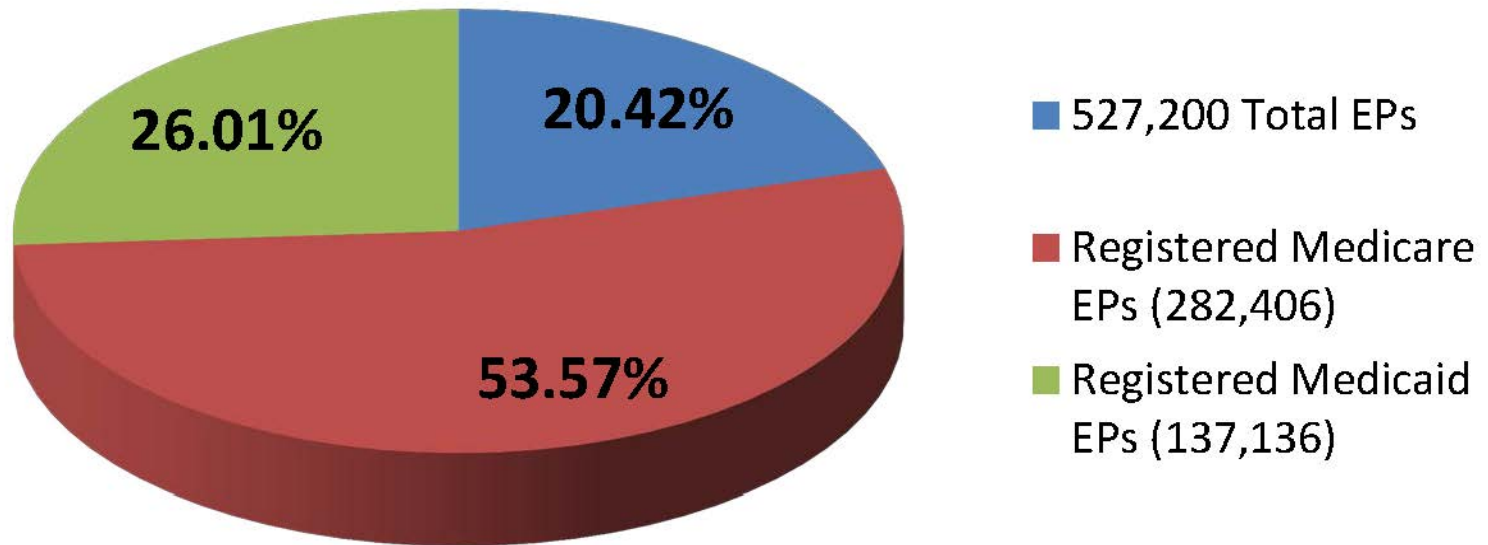
Paid Eligible Hospitals

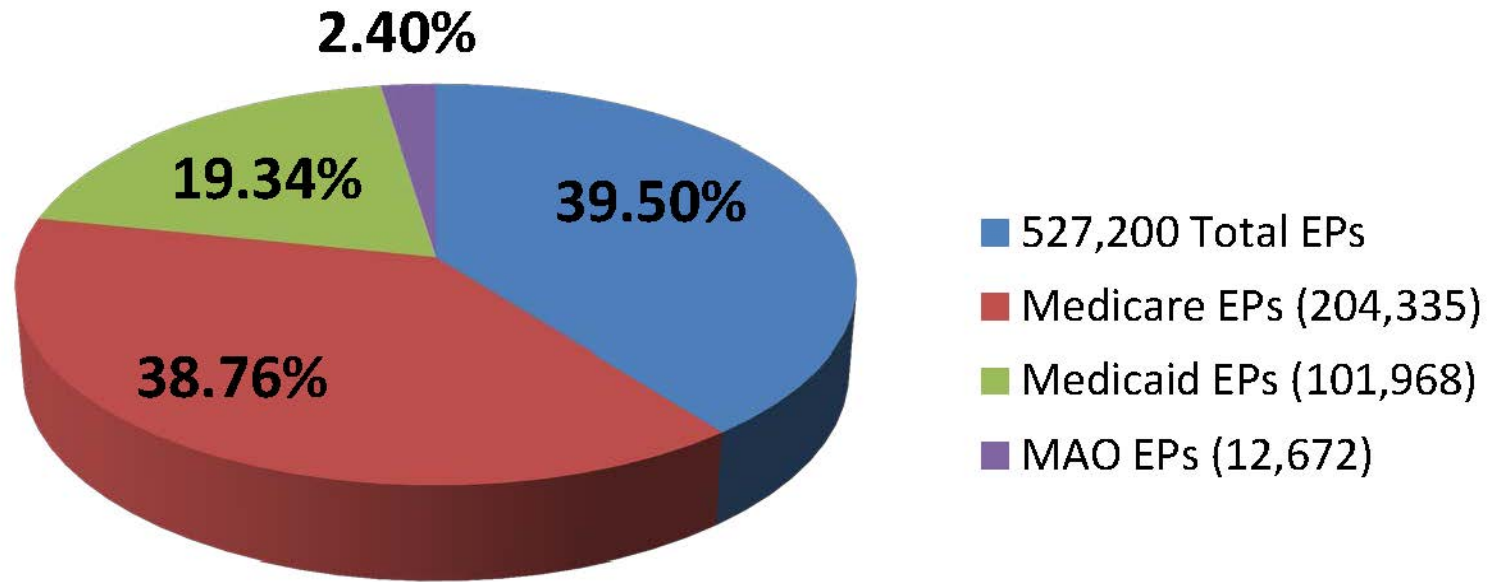

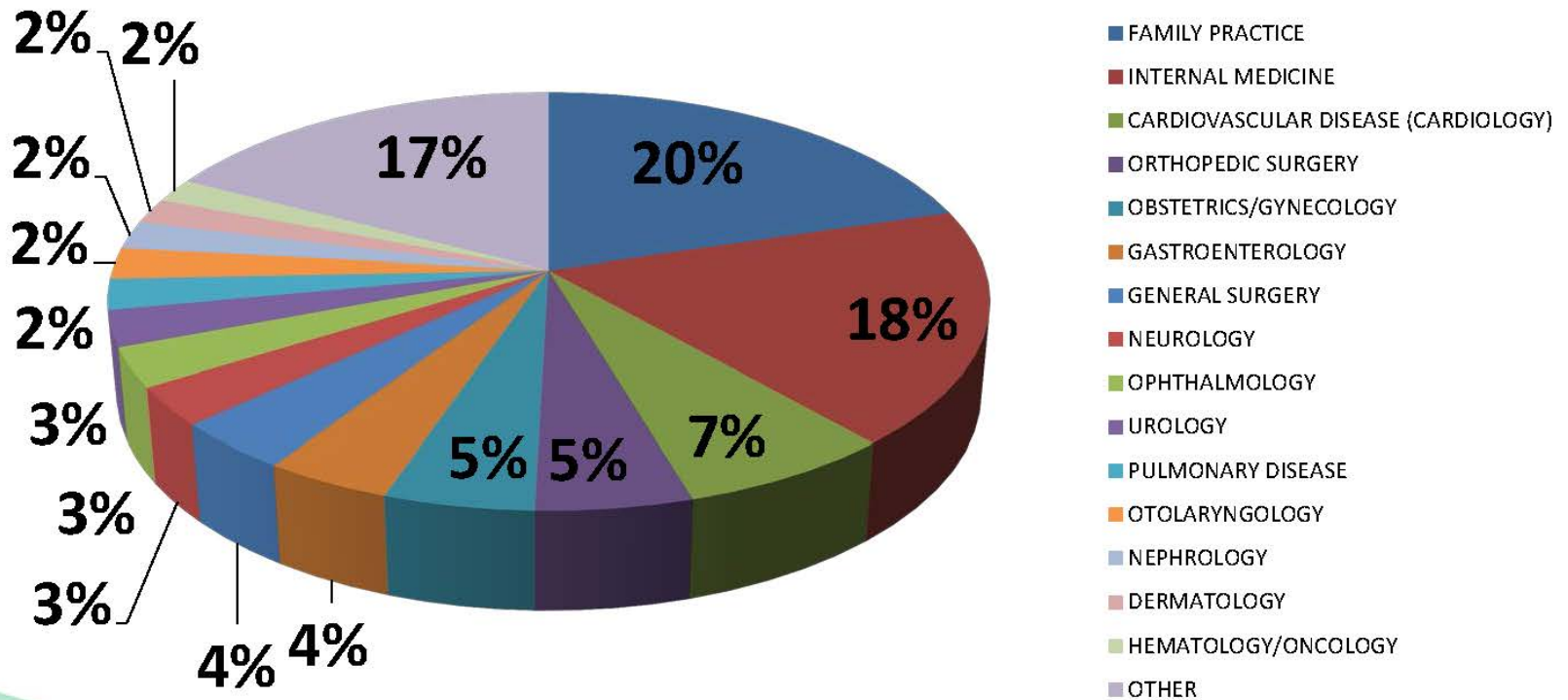

61% of all Medicare EPs who are MUsers are non-primary care





EHR Incentive Program Trends

- Approximately **83% of all eligible hospitals** have received an EHR incentive payment for either MU or AIU
 - More than 8 out of 10 eligible hospitals have made a financial commitment to an EHR
- Approximately 56% or more than **1 out of every 2 Medicare EPs** are meaningful users of EHRs
- Approximately 73% or nearly **3 out of every 4 Medicaid EPs** of have received an EHR incentive payment
 - 16% of Medicaid EPs are meaningful users
- Over 60% -- **3 out of every 5 Medicare and Medicaid EPs** have made a financial commitment to an EHR
- **Over 325,000 Medicare and Medicaid EPs** have received an EHR incentive payment

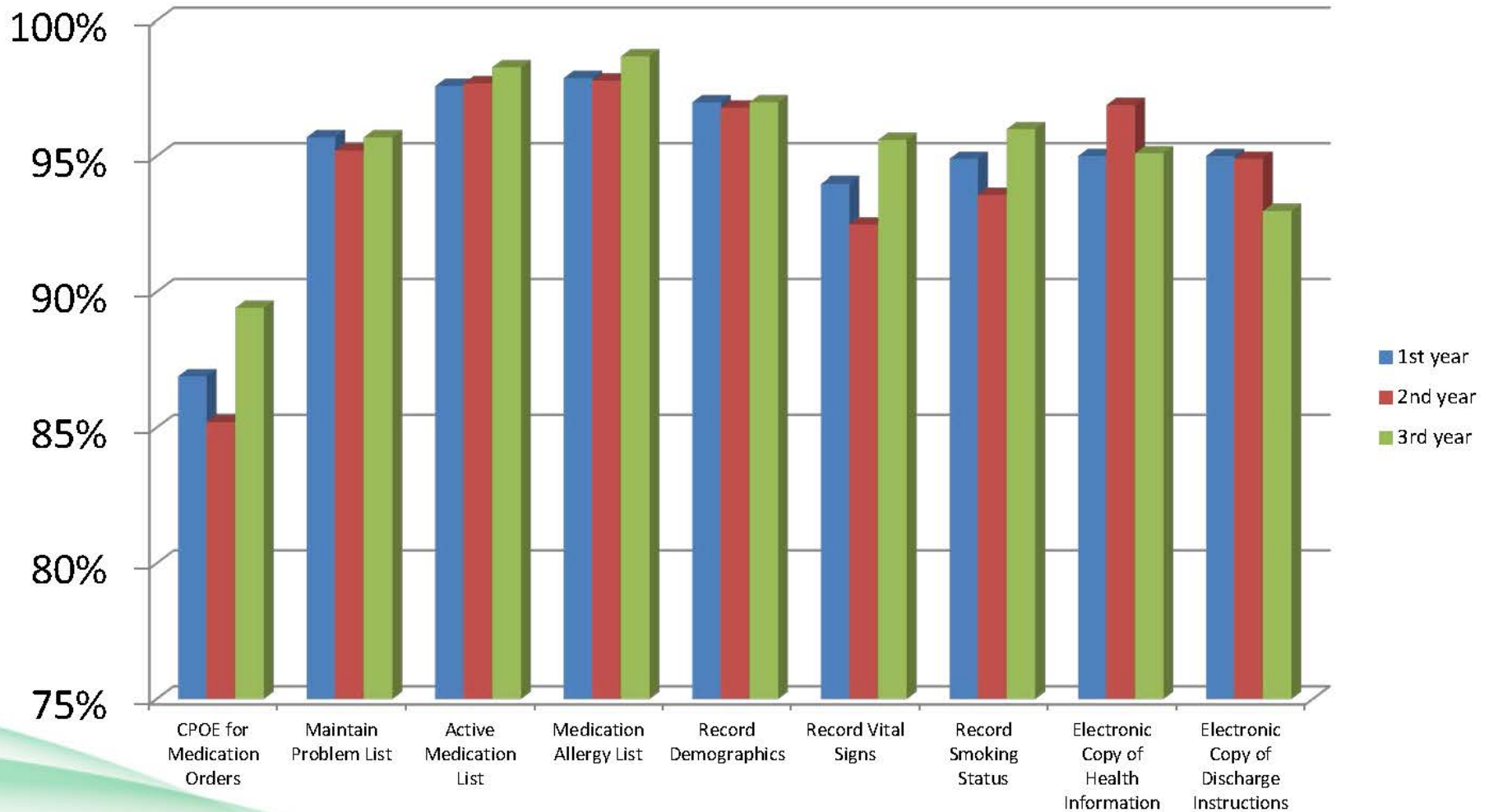

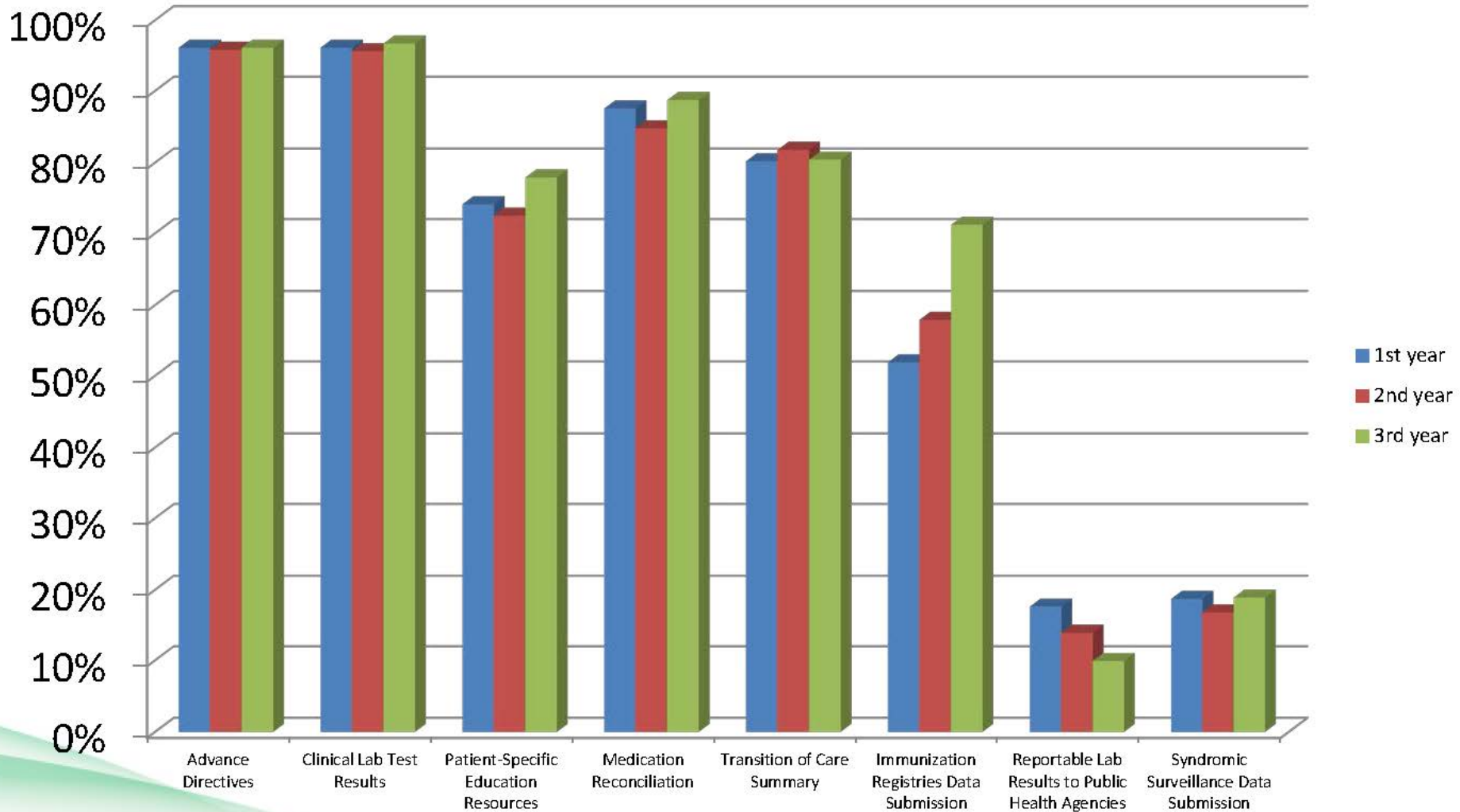


Hospital 1st v. 2nd v. 3rd year Core Objective Performance
