

## Registration for the incentive program continues to increase




Cumulative number of eligible professionals registered with incentive program

- The Medicaid program has different timelines than the Medicare program



- More Medicaid EPs have registered than were originally estimated
- Registration rates have not plateaued yet



#### Proportion of Medicaid EPs scheduled for stage 2 in 2014



#### Summary

۲

- Medicare eligible professionals (EPs) had higher rates of meaningful use achievement than Medicaid EPs
  - 86% of Medicare registered EPs had attested to meaningful use
  - 32% of Medicaid-registered EPs had attested to meaningful use
- Less than half of all Medicaid-registered EPs attested to meaningful use in the year immediately following AIU payment
- Although 4 in 10 registered EPs were scheduled for stage 2 in 2014, progress to stage 2 differed between the two programs
  - More than half (56%) of all Medicare-registered EPs were scheduled for stage 2 in 2014
  - Eight percent of all Medicaid-registered EPs were scheduled for stage 2 in 2014
- More than 9 in 10 EPs scheduled for stage 2 in 2014 were participating in the Medicare arm of the program
